122/10 To accept apologies for absence:

RESOLVED: to accept apologies of absence from Councillors P Couzens and D Major. Councillor J Crossland was attending a planning liaison seminar with ERYC with regard to the new Local Development Framework consultation on behalf of the Parish Council.

123/10 To note the resignation of Councillor Mrs Helen Gilson and that a bye-election will be held if by 11th June 10 electors of the parish give notice in writing to the Chief Executive at ERYC. If no notice is given, the Parish Council will fill the vacancy by co-option:

The Council noted the resignation of Councillor Mrs Gilson. The Clerk read out her letter, the contents of which were noted as out of order.

124/10 To receive Declarations of Personal/Prejudicial Interests on Agenda Items, the Nature of the Interest and Registration of Gifts:

Any declarations of interest made by Councillors are recorded at the appropriate Minute. Registration of gifts – there were none.

Mr Darby outlined the scheme which was run on behalf of the Probation Service. People were given community orders and worked on local projects as Community Payback. Mr Darby outlined the projects already undertaken and how to go about requesting work is done by them. PCSO Feirn stated she had already filled in a form to request the playground to be painted – all that was needed would be materials, ie, paint, brushes. Mr Darby assists with the scheme.

RESOLVED: (All in favour) that Community Payback scheme be requested to paint the playground, the Clerk will see what materials are left over from the previous painting scheme, £100 budget would make up any materials requested and the Clerk will supply a plan of the playground as to which items need painting. Proposed Councillor Emmerson, seconded Councillor Smales.

Street Lighting Contract – ERYC wanted the contract re-writing to take in the new sections as agreed by the Parish Council at the meeting of 10th May – these sections were added to the contract and the previous sections removed. The built in annual price increase was added to the figures and the contract sent to ERYC. The contract has been signed by ERYC and by the Chairman, Vice Chairman and Clerk from the Parish Council and is now in operation.

Pre-School event – will take place on 5th June on the Village Green – road closures, risk assessments and insurance are in place.

Moles, Playground – A further email was sent to Ron Keight (Animal Warden/Pest Control Officer) who has responded that the best solution with regard to safety of the public is to keep raking the mole hills out. There are problems with traps and children and with gassing moles and children which is not advisable. He advises that the moles are likely to move on.

• The Clerk will monitor the position when inspecting the playground.

Toilets Refurbishment – the contractor is due to start work on 14th June 2010. Notices will be put out at the toilets prior to this. The Cleaner had requested leave so the toilets will remain closed for the week until the refurbishment had been completed.

Photocopier – was delivered on 26th May and is operational.

Playground equipment – will be installed shortly – a working party of Councillors Villani, Smales, Grainger and Couzens will remove the old equipment on Monday 14th June at 6 pm. Data Protection – a letter sent to ERYC was acknowledged by Mr Buckley who wanted to know about the particular issue involved. Councillor Mrs Sexton has spoken to him. No formal written response has been received as to whether ERYC intend to take any action.

Street Cleaning – it was reported by a member of the public that Flamborough may lose the street cleaning of the village and that only bins will be emptied. A query was made to ERYC and an Officer (Charlie Sharp) has stated that a full review of all areas will be undertaken and it is not known whether it will happen although given their shrinking budget it may be the case.

Dog poo bin, Rotherhams Right of Way, Woodcock Road – this has gone missing and members of the public are leaving dog bags in a heap. ERYC has provided a wheelie bin for temporary use. This situation will have to be addressed – the Officer at ERYC seemed to think that the Parish Council should replace it.

Litter bin repairs – have been reported to ERYC (the Director who has passed it to Karl Jeffs) who will undertake a review of the bins in question (copy of email enclosed). An email today confirmed that liners and doors will be replaced on a couple of bins and the remainder replaced. 01-03-10 - Flashing Speed Signs – these issues seem to have been resolved.

Local Development Framework Seminar – 7th June, to be attended by Councillor Crossland, 6.30pm, Town Hall.

Slipway, South Landing - work has been completed and it is now operational.

Goal Posts – It was reported on 29th May that one of the goal posts had been pushed over and was in a dangerous position. Councillors Couzens and Woodhouse removed the goal post to make it safe – agenda to consider re-siting.

Seats – Parker Seat has been referred to the contractor. Negotiations are ongoing with regard to land and positioning for two seats (Woodward and Charlie & Edie Good).

Motorcycling, field near Maitlands – members of the public had complained regarding motorcycles being ridden non-stop in a field causing noise nuisance. Diggers had also been there making ramps.

ERYC had sent a report dated 5th May confirming that ERYC had withdrawn from the Memorandum of Understanding with Sustrans for the Connect2 section of the route and that the 6km cycle route from Carnaby Industrial Estate to Sewerby would be installed utilizing the outstanding committed £500,000 LTP2 funding.

RESOLVED: (All in favour) to respond to ERYC that whilst the Parish Council is extremely pleased that the bridge at Danes Dyke will not proceed, it is felt that Flamborough has lost out on a cycle track because the cost of the high level, iconic bridge took funding for the whole scheme way over budget. The Parish Council is disappointed that ERYC did not consider alternative, cheaper options put forward by the Parish Council and proposals to lower costs using alternative means than an iconic bridge to enable the cycle track to come to Flamborough. Proposed Councillor Emmerson, seconded Councillor Smales.

136/10 To consider the enclosed report and quote from LS Lighting & Signs following a site visit on 11th May with regard to wall fixed Christmas Lighting and to consider the way forward (the current installations – anchors and catenary wire do not comply with the Code of Practice):

The report stated that current installations over the highway do not comply with the Code of Practice. Compliance with the Code is necessary to obtain a Licence from ERYC to have Christmas lighting over the highway.

RESOLVED: (All in favour) to go ahead and have four new bolts installed by LS Lighting & Signs in Dog & Duck Square/The Ship area, proposed Councillor Grainger, seconded Councillor Crowther.

The Council will look at electrical wiring options for Post Office Street and purchasing 8 mm catenary wire for the existing lighting strings at the next agenda. Councillor Emmerson will try to get cheaper prices for the wire.

Councillor Woodhouse declared a prejudicial interest (in land earmarked in the potential sites consultation to the rear of his property). He would leave the meeting should the Council

discuss potential sites. He remained in the meeting, took part in discussion and voted as potential sites were not discussed.

Councillor Crossland reported on the consultation event stating that the LDF is a package and the Core Strategy is the mainstay of the framework and is a 15 year forward plan. There were other parts to the forward plan, eg, Minerals, Waste, etc, but the Parish Council needed to look at the Allocations Development Plan Document and Potential Sites Consultation. Two years ago, the Parish Council responded to a similar consultation that Flamborough wished to remain a rural settlement and did not want to be a rural service centre or supporting village and this was accepted by ERYC at the time. Since then, the planners had changed the criteria for the planning documents and revised the whole framework. The current consultation had put Flamborough in the "Supporting Village" category rather than a Rural Settlement.

Supporting Villages are defined as – to sustain the overall vitality of rural areas, small scale development to meet local community needs will be supported, complementing Local Service Centres by meeting the basic needs in remote areas. Development will be supported where it includes: wholly affordable housing, residential development (up to 5 dwelling per year Supporting Village, 10 per Rural Service Centre), new/enhanced local services/facilities and economic development of an appropriate scale.

Rural Settlements are defined as – development will be strictly controlled and will be small scale to meet local needs. Appropriate development is proposed as housing to meet local needs (including affordable housing), small scale business uses, agriculture, sport, recreation and tourism.

Councillor Crossland reported that despite the Persimmon estate and other builds (School Lane/Crofts Hill) being built in Flamborough, many shops and services had been lost since then, for example, Jackie's shop, petrol station, Police and Coastguard etc. Many others were listed as being lost over the last 30 years despite development of the village. This was because of a change in how people live, shop and because they travel to work in other areas so do not spend time shopping and using Flamborough's services. The building of the Persimmon estate had not caused shops and services to remain open in Flamborough. There was a need for some housing, ie, affordable housing and business use but that element is covered for in the definition of a rural settlement. It was also unclear what would happen in funding or policy as a result of the change in Government.

Councillor Crossland stated the question was whether Flamborough wanted to be a supporting village (and if so, the Council should look at the potential sites allocations) or a rural settlement (and if so, the Council would have to fight for it). There was already some land in Flamborough allocated with planning permission.

It was generally thought that the Council did not want any more large scale development as rural settlement status would still allow for affordable housing or small scale development. It was felt that the village would not agree to open spaces being developed.

(b) To consider the enclosed extracts from the Potential Sites Consultation and questionnaire and to consider a response:

It was felt that it was not necessary to consider the potential sites and to put forward an argument regarding the status of the village instead.

RESOLVED: (All in favour) that the Parish Council argue to be a rural settlement and put forward a case for this – Councillors to come to the next meeting with substantive arguments and facts and figures, proposed Councillor Crossland, seconded Councillor Smales.

200/10 To accept apologies for absence:

Apologies were received from Councillors S Crowther, S Emmerson, M Smales and A Grainger. Councillor Crossland is suspended until 6th November 2010.

201/10 To note that an election has been called to fill the vacancy for Parish Councillor caused by the resignation of D Major which will take place on 30th September 2010 and to update on the situation:

The date for nominations for the election to fill the vacancy was noon on 3rd September 2010. Only one candidate stood for election therefore due to insufficient candidates standing, there will not be an election. Kate Johnson is duly elected to Flamborough Parish Council as from 30th September 2010.

202/10 To receive Declarations of Personal/Prejudicial Interests on Agenda Items, the Nature of the Interest and Registration of Gifts:

Any declarations of interest made by Councillors are recorded at the appropriate Minute. Registration of gifts – there were none.

203/10 To receive a presentation from a representative from Yorkshire Wildlife Trust to inform the Parish Council of plans to create a visitor centre to replace the café at South Landing and to consider that information (see enclosed details):

The Chairman introduced Kat Sanders from Yorkshire Wildlife Trust who outlined the position. ERYC own the burnt down café and are keen to rebuild. Yorkshire Wildlife Trust would like to take it on. The proposal is that ERYC rebuild using the same footprint. Planning permission would be required for change of use to a visitor/education centre which would be used for example to conduct surveys, beach cleans, marine awareness, education, etc. There would be a couple of aesthetic differences – perhaps cedar clad, differences around the terrace, and differences due to building regulations eg windows. The centre would be as was but for slight structural changes – there would be an extended room on the back to be used as a shower room. There would be toilets and a small café area serving drinks, ice creams and wrapped food. The proposals were not cast in stone and YWT would consider the project at a board meeting next week. Funding would be provided by YWT and Leader.

Councillor Woodhouse – stated it would be an improvement whatever the YWT did. However he had

been approached at the Parish Council Surgery that evening by residents of the village some of whom were also at the meeting whose views were that the café had become a major part of the village over the years and considerable disappointment was felt for the previous tenant. Kat responded that obviously YWT were not party to the position with ERYC and the previous tenant however it was possible the previous tenant could be involved with the small café side of the new project and she would ask the Council and the tenant what the position was.

Councillor Leppington – commented on the Parish Council's previous request to ERYC that the gate width/road width at the café location is widened when the building is rebuilt because at present it is not wide enough for local fishermen etc for tractors and boats and asked that YWT bear this in mind.

Councillor Leppington – asked whether YWT would be taking on the toilets and whether they would be open full time. Kat responded that keeping the toilets open was a condition of taking on the site.

A resident – expressed concern regarding the idea of cedar cladding as the previous building had been burnt down. Kat stated that there may be something more positive that could be used.

Juin. 041000.

The Chairman - thanked Kat for attending and putting forward YWT's proposals to the village.

204/10 Public Participation session to include items on the agenda (to include members of the public and Councillors with prejudicial interests):

In order to manage the meeting effectively and as there were so many people present, the Chairman asked how many wished to speak. There were three.

Mrs Elliott – stated she had come as a representative of the Allotments Association. The Association was concerned regarding the recent thefts from sheds. The gates had been locked but items had been taken from the site over the gates. The Association was extremely concerned that the Parish Council were not taking on their concerns. Tenants paid rent to the Council -£2,296 last year and only £1117 was spent. The Council had put the car park before security. The Association had offered to pay for new gates if the Council applied for planning permission. Higher gates would not stop theft but would be a deterrent.

The Chairman – clarified that this was an agenda item for tonight's meeting to review this and that the Police would be reviewing security of the site on 13th September.

Councillor Mrs Sexton - stated there needs to be more secure buildings.

The Clerk – confirmed that the allotment site does not run at a profit. The Association had received full details previously on the expenses of the site.

John Crossland — wished to speak on agenda item 16 — the land to the rear of Constable Road. He had been in discussions with ERYC for over a year. The figure talked about for the purchase of the land is considerably less than anticipated. He asked that the Council take this into account and consider the freehold of the site. It is possible that there may be a benefactor for this.

Lara Goodband – introduced herself as the Wingbeats Project Manager. She outlined the project as an arts project inspired by Flamborough and Bempton and which will be participatory – people living in the area will have the chance to attend artists/dance/writing workshops, etc and will explore flight. Adam Strickson is the lead artist who had also worked on the Bridlington renaissance. Between now and next July, she would be contacting as many people/groups/schools as possible to see who would like to be involved. There would be a stage production at Bridlington Spa and in Leeds. The project is part of the cultural Olympiad – the only one in the East Riding – Imove are providing funding for the project, inspired by London 2012. Imove celebrates the relationship between people and their moving bodies through a series of projects. Funding is also being sought from Leader funding and letters of support have been received from ERYC, Imove, YWT and the RSPB. She asked that the Council consider providing a letter of support for the project.

The Chairman – confirmed that this is to be considered as an agenda item and thanked Lara for presenting the project to the Council.

- Annual playground inspection ordered with ERYC as usual.
- Flat swing seats two extra ordered and received.
- Playground damage 27th July 2010 Councillor Woodhouse and the Clerk checked the equipment painting at 9 pm following a conversation with Councillor Grainger that the paint had not dried. On arrival at the playground around five youngsters (aged 10) jumped over the fence to the rear. They had been taking out of the ground the eight inch steel bolts that hold down the new grass matting under the new equipment. There was approximately 50 bolts laid around. The Clerk reported this to the Police and following a PCSO visit, parents of two identified youngsters would be visited. There was no damage to pay for and Councillor Woodhouse hammered the bolts back into the ground.

Seats – Parker, Woodward and Charlie & Edie Good seats have been erected. Parker seat has been paid for and invoices sent for the other two. Wigglesworth seat for North Landing has been paid for and referred to he contractor.

June 10 - Coronation Seat – base down, waiting for seat – with contractor (contractor reported new base damaged on 5th August whilst setting).

ERYC, Issues in Flamborough -

- Footpath on Nature Trail, South Landing ERYC response is that the Public Rights of Way Officers and Asset Strategy Officers have discussed schemes for consideration under the planned maintenance programme. These schemes vie for money with all other schemes. Presently, ERYC are awaiting tender prices for a number of schemes before prioritising which schemes are included in the final list of works.
- Overhanging vegetation, Crofts Hill a team has visited and has cut back the vegetation.
- Verge cut back to hedge on North Marine Road (prevent rat infestation) ERYC response is that
 this is now going to be added into the village grass cutting programme so that it is dealt with regularly.
 Instructions have already been issued for the area to be cut.
- Toilets, South Landing The Parish Council requested that the temporary toilets remain until the situation with the café is resolved and new toilets are built and operational. ERYC response (23rd July) is that the Council would not wish to extend the provision of temporary toilets at South Landing beyond August bank holiday as it is extremely expensive. Discussions are taking place with the tenant of the café if order to bring the site back into use as soon as possible. However, should the Parish Council wish to fund some provision, ERYC will work with the Parish Council to try and assist. Following this, I requested to know how much it would cost for the Parish Council to extend the provision of these toilets and whether ERYC would confirm when the café would be rebuilt and confirm that it will remain a café. ERYC response (4th Aug) is that the estimated cost to extend the provision of the temporary toilets at South Landing would be £850-£900 per week depending on how often they are emptied which presently is twice a week. ERYC did not respond to the point as to when the café would be rebuilt or confirm that it would remain a cafe. I had already heard from other sources prior to this that Yorkshire Wildlife Trust would take on the area and build a visitor centre incorporating a small café.

External Audit, Annual Return 2009-2010 – returned to us – the Annual Return is in accordance with the Audit Commission's requirements and no matters have come to out attention giving cause for concern that the relevant legislation and regulatory requirements have not been met. An extra £20.00 had been invoiced by the Audit Commission because of an error on the Return that was corrected and re-approved by the Council in June. A notice was placed 2nd August 2010 for two weeks as required stating that the audit has been completed and the Annual Return is available for inspection by local government electors.

Tree Pruning, Village Green – took place on 30th July. There have been a lot of comments from members of the public as to how much better this looks now.

Allotments -

- Allotments broken in to and items taken from sheds on 12th/13th August. This was reported to the Police by the Chairman of the Association.
- Allotment dispute please see confidential agenda item.
- Hedge cut ordered with the contractor when he is in the area in the autumn as usual.

CSV Action Earth Grant - £46.80 received

Peter Traves – contacted the Clerk on 5th July and reported that he was not happy with the reports in the Free Press about him no longer being a Councillor or the way the Good Councillors Guide is written stating that no dates are given as to the six months rule and that his date had not run out on 3rd May. He had been to see a no win no fee solicitor who had told him he would have a good case. He did not say who against. I stated I had received legal advice from both ERNLLCA and ERYC regarding his position as Councillor

and the six months rule however I was unable to help him with regard to reports in the Free Press or how the Good Councillors Guide was written and he would have to contact them separately. He was unhappy that the dates were not made clearer. I indicated that ERNLLCA run regular training courses for Councillors but that Councillors were generally in the knowledge of the six month rule as this has been discussed previously by the Council. For clarification, the legislation is Section 85(1) of Local Government Act 1972 which states:

"...if a member of a local authority fails throughout a period of six consecutive months from the date of his last attendance to attend any meeting of the authority, he shall unless the failure was due to some reason approved by the authority before the expiry of that period, cease to be a member of the authority". ERNLLCA state – it is the responsibility of the councillor to approach the council regarding any "leave of absence" and there are a couple of situations where the council is compelled to accept absence and these centre on serving in the armed forces or working abroad on a contract commissioned by the Government. Apart from that, a council is under no obligation to grant a "leave of absence" and it should be noted that a third party cannot make an application on the councillor's part.

For Councillors' clarification, the date runs out exactly six months from the date of last attendance – the date of Peter's last attendance was 2nd November 2009, therefore a vacancy existed as from 3rd May 2010.

20 mph Speed Limit Consultation – ERYC has confirmed that no further action will be taken in

History Storyboard - has been erected at Camerons Gardens on 20th August.

Flamborough with regard to 20 mph speed limits.

Goal Posts – were removed from the Village Green following a phone call from Councillor Sellick that youngsters had brought them down. Thanks to Councillor Couzens for prompt attendance and removal from site. This has been logged with the Police.

Coastguard Station – Ward Councillor Harrap asked whether there had been any problems with the relocation of the station. Councillor Leppington reported on one instance at South Landing where Coastguards were unable to help stranded persons on the beach as no personal life saving equipment was available in Flamborough.

PCSO Feirn – emailed a report for the Parish Council – there had been 5 ant-social behaviour logs in July and 5 in August. Also one public notice for disorder issued for supplying alcohol, two youths issued with £50 for attempting to buy/ask persons to buy alcohol. 10 letters sent to parents informing them their children are drinking under the age of 18 following reports in Camerons Gardens. She is trying to gain two ASBOs in the Village.

Apple Tree, Camerons Gardens – residents of Castle Crescent had written regarding the crab apple tree and youngsters throwing apples, requesting that the tree is removed and replaced with another non-fruit bearing tree. The ERYC Tree Officer had also written as the tree is in a Conservation Area. These letters were too late for the agenda and will be considered at the next meeting.

The Council noted the election of Kate Johnson to the Parish Council. Councillor Mrs Johnson had signed the Declaration of Acceptance of Office prior to the meeting.

213/10 To receive Declarations of Personal/Prejudicial Interests on Agenda Items, the Nature of the Interest and Registration of Gifts:

Any declarations of interest made by Councillors are recorded at the appropriate Minute. Registration of gifts – there were none.

214/10 PCSO Feirn will introduce the Community Speeding Initiative to consider following concern expressed by the Parish Council regarding speeding on North Marine Road and South Sea Road:

PCSO Feirn outlined the scheme and gave out details. The Neighbourhood Policing Team would work with community volunteers and the support of the Parish Council was required. PCSO Feirn, a neighbourhood officer and volunteers would undertake speed checks, identify vehicles and car registration numbers and letters would be sent to speeding drivers regarding their action. The purpose would be to collate information to pass to the Traffic Department so that they could target resources. All volunteers would be trained. Previous trials in other areas had been successful. Two volunteers from North Marine Road, which the Parish Council had already identified as an area of concern, had put their names forward. If anyone else wished to take part they must give their name to PCSO Feirn. The project is initially a trial.

Councillor Mrs Sexton – expressed concern as this is a police/law enforcement matter.

RESOLVED: (8 in favour, 1 against) that the Parish Council would support the scheme and advertise it in December's newsletter, proposed Councillor Leppington, seconded Councillor Mrs Johnson.

Councillor Couzens arrived at the meeting.

215/10 Public Participation session to include items on the agenda (to include members of the public and Councillors with prejudicial interests):

PCSO Feirn - reported that

- The offender who damaged vehicles in the village would not be charged because witnesses would
 not make a statement. They had one statement which was not enough and therefore the offender
 got away with it. She asked that to help the Police, members of the public need to report incidents
 and be prepared to make witness statements.
- She hoped that the Council would agree to remove the crab apple tree from Camerons Gardens as the apples are being used as missiles.

Lim. OZNIO.

- Information is being put together towards another ASBO in the village which should go to court.
- There were only 4 anti-social behaviour logs for September. Anti-social behaviour was going on but the public was not reporting it she was aware of more incidents. There had been trouble in Camerons Gardens and the Cricket Field. The allotments were a priority due to the burglaries.

Chairman – asked if anyone had any questions for PCSO Feirn but there were none. PCSO Feirn then left the meeting.

Mrs Elliot – had been approached by someone who helps a tenant on the allotments but was aware that if the tenant gave the plot up, they would not have any right to the plot as their name was not on the Tenancy Agreement. Would it be possible to add these names to Agreements as there were a few helpers on site? The Council will consider this at the next meeting – the problem was queue jumping the waiting list.

Mrs Elliot – asked whether the Council had previously got estimates for new gates to the allotments. Clerk – reported that the Council did get estimates, however, new estimates would now be required. John Crossland – was concerned that on a previous evening the gates to the allotments were open at around 8 pm, it was pitch black and someone had a wheelbarrow. He had telephoned PCSO Feirn who was at a meeting in Flamborough and stated she would call round. He wanted to know if she had. Clerk – reported that PCSO Feirn had let her know that she had called round and the gates to the site were shut. It was a shame he had not asked the question when PCSO Feirn was still at the meeting. Mrs Elliot – confirmed that PCSO Feirn had been to the allotment site and the gates were shut. John Crossland – reported he felt strongly about the land to the rear of Constable Road as he had worked hard for 18 months chasing it up, the Parish was lucky to have been offered the freehold at such a good price and the Council should grasp it as soon as possible. If anyone has a free tip site which they have access to and would like some mulch please contact Lee Trivett, ERYC Parks and Open Spaces Officer on 01482 395873.

• The Clerk will ask for some to be placed at the allotments.

Flamborough School – At the start of the new school year, Headteacher, Mrs Tandy, followed up queries and concerns regarding the shelters and reported that there had not been any evidence of anyone on the school grounds, no problems with the shelters, litter or damage over the summer – there have not be any Police logs.

Flamborough School – an 11 million takeover day would be held on 12th November – the Headteacher wished to warn residents that it will be very noisy on that day as there will be police,

fire, ambulance, coastguard, dogs and helicopter visiting the school.

"Flamborough" Sign, Bempton Lane Trough – this was reported stolen to us on 16th September. Future of Standards Regime – ERNLLCA had corresponded to say that a briefing from NALC had been received that stated that the Localism Bill due to be put before Parliament in October or November will seek to:

 Abolish the whole standards regime applicable to Councillors in England – the Model Code of Conduct, Standards Committees, the Standards Board for England, and the Adjudication Panel for England.

• Implement arrangements for the determination of existing complaints as at the date of abolition of the regime. The Standards Committees will be required to determine all existing complaints within a stipulated timeframe and thereafter their role and function will cease.

 Ensure that Councillors will have to register certain personal interests in a publicly available register

 Create a new criminal offence if a Councillor fails to register relevant personal interests or deliberately seeks to mislead the public about such interests.

 Introduce a power for Councillors to vote on matters they may have a predisposition to but not have predetermined. This may permit Councillors to speak and vote on matters they have been elected on or have an interest in.

• Introduce powers to strengthen the role of the Local Governments Ombudsman but it is not known how.

Further detail will be available when the Bill is before Parliament. The Bill is not expected to receive royal assent and become legislation until at least July next year and unlikely to take effect until the end of 2011 or early 2012. Therefore the current Code remains in existence and is likely to do so for some time to come.

not yet been sought until it is known whether the Parish Council can proceed. A notice of decision will be sent to us — we have not yet received the application back to comment on as a Parish Council consultee. **Street Lighting Inventory** — has been completed by ERYC and will be sent to CE Electric.

Salt Bins – ERYC has responded to the Parish Council's request for reasoning why a bin does not meeting their criteria for siting at the top of Allison Lane.

"Freeze" on Council Tax levels – a briefing received from ERNLLCA states that a consultation document was issued recently regarding the Coalition Government's plans to freeze Council Tax levels which would also apply to Parish Councils as Local Councils. The Parish Council noted this in July this year. However, the Secretary of State for Communities and Local Government has revealed that this will NOT apply to Parish Councils.

State of Pavements in Flamborough – the Parish Council's request to review the village with regard to repairing pavements and dropped kerbs has been forwarded to the Director of Policy, Partnerships and Improvement as it is his department that is responsible for prioritising work – no further response has been received.

Litter Bins – ERYC has undertaken some work to repair and replace litter bins in the village.

Woodland Trust – responded to the Parish Council's query with regard to path cutting and dog problems. Grass Cutting – 11th October operative the contractor's operatives were wearing PPE and they did trim and weed Fishermans Gardens and Camerons Gardens. No response has been received from the contractor with regard to spray sheets/data sheets – not known whether weedkilling has been undertaken.

Notification of Tree Work, Camerons Gardens — Notification has been received that ERYC has no objection to the proposed work — Councillor Couzens will remove the tree. The rest of the tree work will be put out to tender.

State of Pavements in Flamborough – ERYC has provided a response – please see enclosure in agenda item "Correspondence"

Litter Bins – ERYC will charge for one bin as agreed following the recent work. ERYC state the replacement bins were of great capacity and cost. Some liners and locks were also replaced.

Footpath Nature Trail, South Landing – ERYC state that they accept that work is required to improve the condition of the disabled access trail at South Landing. ERYC are looking to carry out the necessary works and are drawing up a schedule of works that can be tendered. It is hoped to complete works before the end of March 2011.

Café, South Landing — a complaint was received from a resident of Flamborough regarding the time ERYC are taking to resolve this issue and this was forwarded to ERYC. ERYC responded that a reply will be sent to the complainant. ERYC state "some slow progress towards rebuilding the premises" is being made as ERYC has to extricate the building from the previous tenant and the surrounding insurance issues and transfer to the new tenant.

Static Caravan, DIY Shop, Bempton Lane – ERYC Planning Enforcement Officer responded that an agent contacted him some months ago and a planning application was being prepared. He will follow up. Parish Council Logo – The School will undertake this after Christmas.

Annual Playground inspection—this was undertaken during November—we now await the report. **15-02-10 - Bus Stops**—Following the site meeting on 15th February 2010, the Transport Officer indicated that proposals with regard to altering bus stops (eg end of Allison Lane) would be put together in writing for the Parish Council's consideration. The Parish Council recently requested an update. The Officer stated with regard to altering the bus stops that when the details of the meeting were passed upwards, the Officer was informed that this was an old issue which had already been discussed at a much higher level than her and had been rejected and that she should do nothing. She could only suggest that Councillor Crossland go back to whoever vetoed the changes last time.

East Riding College – Councillors Woodhouse and Sellick visited the Public Services Course on 22nd November 2010 to talk to students and answer questions about being a Councillor and the democratic and electoral process.

Log Walk - repaired by Councillor Grainger on 2nd November.

Posts, Village Green – these were left when the signs put in by Councillor Crossland were removed by vandals and not replaced – Councillor Crossland was due to replace the signs, however large stones were put on the Little Green. The post stumps were cut off by Councillor Woodhouse on 2nd and 5th November. **Leak, Toilets** – a leak on the basin in the mens toilets was repaired by Councillor Woodhouse on 20th November.

Yorkshire Water – drainage/sewer improvements on North Marine Road to start week commencing 13th December. There will be a new sewer and sewage pumping station. The project is hoped to be completed by April 2011. Traffic signals will be in operation for some time.

Xmas Lights – are in the process of being erected. They were delayed due to the weather.

ERYC Emergency Committee – are sending emails regarding the severe weather which are being circulated to Councillors with an email address and put on the website.

PCSO Feirn had sent a report:

- An ASBO was applied for but is not going ahead as the person involved has not offended since August.
- Her new mobile phone number is 07592302277
- A meeting will be called of the Headlands Community Group with a view of dissolving it. This is not due to a lack of venue for a community centre but a lack of community involvement. 2-3 people are needed to take the project forward. It will mean that funding already given to the project will be lost £5,900 from the YOF for computers, £600 from Headlands School, £500 from the Police authority.

Grounds Maintenance contract – has been terminated and a tender notice is in the Free Press this week. For £40 this could be included on the Yorkshire Post website for a month. The Council agreed to leave this for now.
